MARDI GRAS BALL II A SUCCESS

January 1, 1966's Mardi Gras Ball No. II, sponsored by the Privy Council of Empress Jose de San Francisco as a benefit for the various homophile organizations, was a financial and swinging success.

The massive and monstrous police activity of Mardi Gras Ball No. I was not repeated this year, and police surveillance was superficial. No arrests were made and everyone seemed to have a delightful time, including the special police officers who by now seem a standard fixture. The donation made by each guest ensured ample beverages for everyone during the even-

The large crowd in attendance at the 1965 Ball, however, did not turn out for this Ball, which was designed to achieve more than just entertainment for the homophile community and its friends. Those who attended were exhibiting a vote of confidence in this method of proving that individuals have a right to gather in public regardless of their sexual proclivities, and that one doesn't have to belong to a gathering at the Bohemian or Olympic Club to have this right respected by the police.

SO. CAL. ACLU POLICY ON SEX

SIR has received a letter from Mr. Vern L. Bullough, chairman of The Sex and Gender Committee of ACLU, stating that on December 14, 1965 the Board of the Southern California ACLU adopted, without a dissenting vote, the following policy statement. On December 15, 1965, the union entered its first case in this area, an attempt to prevent revocation of the state certificate of a teacher accused but not convicted of homosexual conduct.

STATEMENT

General Statement

The American Civil Liberties Union of Southern California believes that the right to privacy in sexual relations is a basic constitutional right. Each individual has the right to decide what kind of sexual practices he or she will or will not engage in, what techniques will be used, and whether or not a contraceptive should be used. Public regulation of sexual conduct should be concerned only with preventing rape and assault and the protection of minors.

Definitions

Rape, gross sexual imposition, corruption of minors, sexual assault, and indecent exposure are clearly and adequately defined by the proposed official draft of the American Law Institute section 213 on sexual offenses. Definition of minor is also set forth in this section.

Argument

What the proposed statement does is to make legal any kind of sexual behavior between consenting adults, as long as force or violence is not used. The most controver

The ministers and counselors, along with the high school students who comprised the heterosexual part of the gathering, were very impressed with the presentation. These confrontations are of great value to all who participate and it is too bad that all heterosexuals cannot talk openly to homosexuals, on a person to person level, at some time in their lives.

I can remember when the Board of SIR first proposed that our Religious Chairman consider such a program. I am happy to see it in action under the CRH. All members of this particular group are active SIR members.

My only regret is that there are not more homosexuals involved in this or in an equally important program. There is so much to do and far too few who, as yet, have joined in the doing of these self-rewarding tasks.

What thrilled me most was that homosexuals made effective public presentations of rationales that only a short year and a half ago, I felt that I alone was publicly advocating. I must endorse one observation of that evening; "Can you imagine this happening ten years ago? We have come a long way in a short time."

The reason for this astounding progress has been the courage shown by those who have participated in such programs and by the justice of our cause.

But we must also observe that there is much to be done. We have just vitalized a movement to meaningful activity. We must extend these confrontations so that all parts of our local community are affected. We must capitalize on these successful processes so that all across the United States similar presentations can benefit all communities.

ANOTHER CHAPTER IN THE DORN AMENDMENT

The Dorn Amendment, which we unalterably oppose on the ground that it is a deceptive and vicious play for power on the part of city governments, has been submitted to the Governor with the expectation that it will be passed on to the Legislature for favorable action either in the Budget Session this year or in the Regular Session of the Legislature in 1967.

Should the Legislature enact the provision into law, it would become a statute and not a constitutional amendment, and, hence, could be modified or repealed by the Legislature at a subsequent time. But the law would, so far as its effect is concerned, achieve the same result for cities and their police departments as would a constitutional amendment, and at the same time it would (1) prevent a vote on the issue by the people, and (2) save Mr. Dorn the task of getting the required number of signatures on his petition.

We believe without reserve that matters of sex and morals are not local in nature but are matters of State-wide concern and that any laws in this area should affect all the people of the State in the same manner and to the same extent. Therefore, any laws on the subject should be State laws. Conversely, we do not believe that any city or cities should have the right to enact more stringent and different laws in this area. Municipal Codes, which are often badly organized and not easily obtainable, could, with the inclusion of innumerable laws on sex and mor-



the TENDERLOIN PROJECT

by Reverend Ed Hansen

The "Tenderloin" is in the heart of downtown San Francisco. It is notorious for prostitution, "gay" bars and hotels, drunkeness, sexy news stands, etc. The district includes such key places as the Greyhound Bus Depot, the Y.M.C.A., several blocks of Market S t r e e t, hamburger stands, numerous restaurants, bars, hotels, and the Glide Memorial Methodist Church. During the day the streets are jammed with cars, cable cars, trolley cars, and buses; the sidewalks are crowded with people hurrying every-The clamor of so much activity drowns out the distinctive human sounds of individual persons, and one is easily lost into anonymity, into nothingness in the midst of crowds. The daytime clamor is subdued in the evening, and individual sounds begin to take on importance. footsteps on the sidewalk and conversations at street corners mark the beginning of night-life in the Tenderloin. The "method of response" is a helpful concept for me

The "method of response" is a helpful concept for me as I work with the youth and young adults in this area of San Francisco. Simply stated, the "method of response" demands that we be sensitive to the needs of human beings and respond to them with the ways and means that will meet the needs. This is a very basic concept of ministry and yet I'm sure it is often ignored by ministers and congregations alike.

According to the method of response, we don't approach people "program first". We don't impose upon them the ways that have had meaning for us. Instead we associate openly with the people we want to serve; we listen and try to empathize; we involve ourselves in their lives until we come to know their greatest needs. And then in response we search with them,

WATCHDOG OF LIBERTY

Dew vs. Halaby, Administrator, Federal Aviation Agency, et al., 317 F.2d 582 (1963) is an especially interesting case where an employee was discharged for anti-social acts which

occurred when he was a teen-ager.

The Central Intelligence Agency gave Mr. Dew a lie detector test. This was done preparatory to promoting him to a security position. During this test he admitted committing at

or test. This was done preparatory to promoting him to a security position. During this test he admitted committing at least four unnatural sex acts with males, some of them for pay, when he was 18 or 19 years old. He also admitted having smoked marijuana cigarettes on at least five occasions while in the Air Force. Dew was "allowed" to resign.

He next was employed by the Civil Aeronautics Authority where he worked successfully as an Airways Operations Specialist for some twenty months. Then when that agency came into knowledge of the teen-age episode, it removed him.

The first removal was badly handled administratively; consequently, a suit in the United States District Court asking for reinstatement was ultimately granted. The agency reinstated him, and then proceeded to fire him all over again, this time giving him a pro forma administrative hearing before doing the inevitable. Again, Mr. Dew sued the concerned parties in the U.S. District Court for the District of Columbia, and this time he lost. Judge Alexander Holtzoff granted the government's motion for judgment without giving Mr. Dew any hearing. Mr. Dew then appealed to the United States Court of Appeals for the District of Columbia Circuit which affirmed the lower court. affirmed the lower court.

The appellate court stated: "The crucial question is thus

The appellate court stated: "The crucial question is thus whether it is arbitrary and capricious, as appellant [Dew] argues, to base removal for such cause as will promote the efficiency of the service on pre-employment conduct of the employee, under circumstances like those here."

The Court ignored the undisputed, lengthy, and factual evidence of a psychiatrist who testified at the second hearing with the agency. The Court chose to get hung up on technical rules of procedure, made ignorant and prejudicial statements of folklore, and ignored its equitable jurisdiction. It conveniently washed its hands by rationalizing the deed onto others. others.

A fine dissent by Judge Wright attacked the opinion of the majority. He said it is unfortunate that it is adolescent acts by Dew which are being used as a springboard to attack the protection of the Civil Service worker. "If this ruling remains the law," he said, "no Civil Service job is safe."

Mr. Dew then took his case to the Supreme Court of the United States. The government (the C.A.A. and the Solicitor General for the Justice Department), realizing that its shoddy performance would in all probability be disapproved in a most definitive manner capitulated! The last thing it ever believed could happen had happened - the Supreme Court was going to hear a homosexual case and applened - the Supreme Court was going to hear a homosexual case and apply the United States Constitution to the rights of this minority group. The government thereupon reinstated Mr. Dew, gave him promotions he had missed, and compensated him for lost wages. This settlement by agreement of the parties rendered the case moot, and it was therefore dismissed by the Supreme Court.

Mr. Dew's case should do much to give courage to the homo-phile community. It shows what belief in one's self and individual action can accomplish --- SUCCESS:



utilizing all the resources we can muster, to help them find the ways to meet their needs.

As I began working with the young adults who live in the Tenderloin, I felt some sort of coffee house would be a likely approach for ministry in this area. But this would have been coming at these people "program first". Perhaps a coffee house is needed, but for now this is set aside and I am concentrating on becoming better acousinted with the people themselves, and then as their greatest needs become known, I must work with them in search of the answers.

My work is taking me into the Tenderloin at least two nights weekly, and the days have been filled with counseling and interviews with key persons in San Francisco. To discover existing resources, to counter the problems we have discovered, Mr. Mark Forrester and I have talked with persons in the police department, California Youth Authority, Juvenile Court, Department of Education, counseling centers, hospitals, Traveler's Aid, United Community Fund, and universities. Also we have talked with people in the Jewish, Roman Catholic, and Protestant faiths. As we talked with the "professionals," it became more and more apparent that all of us need to involve ourselves more directly in the lives of those we are trying to serve. We just cannot do it from behind a desk.

sial aspect of this policy is to legalize homosexual conduct (used in its broadest sense to include transvestism etc.) as long as minors are not involved and force is absent. Since this is the most controversial aspect of the statement, it might be well to give a general synopsis of the legal practices in the several states as far as ho-

mosexuality is concerned.
It should be made clear from the first that at present it is not a crime to be a homosexual, but it is to perform a homosexual act. Some states provide separate definitions of and penalties for particular homosexual offenses, others set forth a vaguely phrased, catch-all offense such as unnatural crimes, the infamous crime a-gainst nature, any unnatural copulation, the abominable and detestable crime against nature with mankind or beast, any unnatural and lascivious act. Usually these catch-all phrases lack the degree of specificity which is required in the statutory definition of other crimes. Moreover, the penalties at least theoretically imposable for homosexual acts are harsh ones. Several states provide a maximum penalty for some homosexual offenses of ten or more years in prison. In some jurisdictions the homosexual may be subject to long-term incarceration, ostensibly for treatment, under special "sex offender" or "sexual psychoor "sexual psycho-ws. These laws path" laws. which establish an extremely vague "waste basket" category offenders and allow for commitment with less than the usual criminal safeguards are often applied against minor sex offenders, and not just as a means of isolating dangerous sex criminals. Obviously the statutory regulations do not in themselves provide a realistic picture homosexual's legal of the status since judges and juries vary and there is considerable reluctance to impose stringent sanctions against homosexual defendants in most

cases. Often the great damage is not done through punishment, but through arrest

and exposure. The vagaries of judges, juries, and the difficulty in apprehending the average homosexual means that the problem of police enforcement is difficult. Since there is a willing exchange of services, there is usually no complain-ant except in those instances where force has been used, blatant public display has taken place, or where child-ren are involved. When the behavior occurs in relative privacy, as is usually the case, it does not normally become known to law enforcement authorities. Thus the police are placed in a rather difficult if not intolerable position. Under great pressure from some segments of the public to eradicate the offending behavior, and at the same time knowing full well the essential unenforceabili-ty of the law, they have fallen back on an amalgam of unsavory vice squad techniques or of "looking the other way." In the larger cities there tends to be a fairly routine patrol of public places frequented by homosexuals, with intermittent arrest. Often the police become agent provocateurs be-cause it is argued that only by such techniques can the existing law be enforced. This sort of argument seems a

Law enforcement activity is also directed at such known homosexual meeting places as "gay" bars. Plain-clothesmen are often stationed as decoys in such establishments and legal action is periodically taken against the bars themselves, usually on the basis of "disorderly conduct" or conduct "contrary to public welfare or morals." State liquor authorities have been particularly active in this regard, although the courts in California have not always gone along.

In sum, the enforcement policies affecting sex behavior are at present very confused. This general statement is couched in terms of "constitutional right" because of the recent decision

of Justice Goldberg in Griswold v. Connecticut. Judge Goldberg applied the Ninth Amendment to marital privacy and it could just as well be applied to the whole area of sexual conduct. Much of sex is legitimately beyond the interests of the state. In fact much of sex law is taken over from religious law. What ever m o r a l restraints a church may wish to impose upon its members need not be made legal prohibitions imposed upon all citizens.

-I dig your point of view, chum, but if all the members



Here's to a better attended Ball next year with as much privacy as this one had!












