#### NISEI SUBJECT TO DRAFT CALL

#### Local Boards to Notify Registrants Here

Japanese-Americans (nisei) who have relocated in the Omaha area Saturday became subject to selective service.

The Omaha office of the war relocation authority was notified by its Washington headquarters that the war department has completed plans for "reinstitution of selective service procedures for American citizens of Japanese descent,"

I. B. Zimman, publicity director for the Omaha draft boards, said the new regulation has been received here, and that the boards are now notifying the nisel registrants of the change. Under the new regulation, he said, selective service boards will send information forms to the Japanese-Americans, and after return of the forms the war department will make individual investigations on the acceptability of each registrant.

Only after the war department has approved the individual, Zimman said, will a selective service board act, and "thereafter the individuals will be processed just as any other citizen."

Mrs. Adah L. Eier, counsellor in the Omaha WRA office said the order will affect a majority of the male Japanese-Americans who have been resettled here. Those who have learned of the change, she said, expressed eagerness to get into service.

Previously, Japanese-Americans could volunteer for service if found acceptable by the war department and Zimman said Saturday that "those we have processed in Omaha are making good."

The folks in Lincoln, Nebraska, have been invited, and we are hoping some of them will be able to come to the party so we can meet them.

#### IMPORTANT DIRECTIVES FROM WASHINGTON

Director Dillon S. Myer has asked us to notify all <u>Nisei men</u> of military age who are not certain that they listed complete information concerning local selective service boards at the time of registration early in 1943 to send their name, number and address of their boards to the relocation planning division, Washington, D. C. The address is Barr Building, 910 - 17th Street, N. W., Washington 25, D. C. While induction will be a gradual process, it is essential that the records of each individual be brought up to date at once.

Nisei men of military age are reminded also of the importance of keeping selective service boards notified of all changes of address. Responsibility for such notification rests with the individual. A man who cannot be located and notified to appear for pre-induction physical examination when his order number appears will be reported as delinquent and is liable to severe penalties provided under the selective training and service act.

We have also been asked to notify <u>aliens</u> on leave that they may not travel without first having secured a travel permit from the United States District Attorney. This includes return travel to the project.

After an alien has secured a travel permit from the U.S. District Attorney and reached his new destination a notice of the change of address must be sent to the Federal Bureau of Investigation and to the Immigration and Naturalization Service. Special post cards for this purpose may be obtained at any Post Office.

Failure to comply with Department of Justice alien travel registrations will cause troublesome complications and may result in serious penalties.

It is the desire of Mr. and Mrs. Warren to make the evacues in Omaha feel that the Warren home is a place where they are welcome to go <u>at any time</u>. Mr. Warren's parents were missionaries in Japan for over forty years and the same kindness and sympathy is possessed by the Warrens here in Omaha who have opened their hearts and home. Mrs. Warren has designated every second Sunday and every fourth Saturday of the month as a day of open house for the evacuees to consider themselves as guests in their home. Desire immediate contact by mail with all possible candidates in your area. Request all prospective men of draft age write Captain Paul Rusch, Director of Personnel Camp Savage, Minnesota at once. Fullest cooperation your staff will be of great value to war effort." DID YOU KNOW THAT - Now you can get all your household effects from the Center on Government expense--not just 500 pounds. Also, now you can get not only your household effects from your former home on the west coast, but also 5,000 pounds of tools of trade which would include tractors, plows and other farming implements in case you are a farmer. All this at government expense!

Leaves from the Center for your Friends and Relatives - We still have the indefinite and the short term leaves. The seasonal leave has been changed to strictly agricultural occupations and may be of seven months' duration. The County Agent in the county in which the work is to be done must determine there is a need for such labor, and the War Foods Administration will take charge of transporting workers in furtherance of the War Food Production Program.

If you are interested in obtaining your personal property from California or are considering leasing or selling any property, our office, 202 City National Bank Building, will be glad to help you. It is still necessary to get a military permit to go into the Restricted Area.

#### NEWS AND HIGHLIGHTS

May 30, 1944

A few days ago the Omaha District office celebrated its first birthday. On May 4, 1943, on the twelfth floor of the City National Bank Building, our relocation office was opened, with two persons on the staff--Mr. W. N. Parmeter and Mrs. Adah L. Eier. In August, Miss Lucie Kawafune of the Minidoka Relocation Center reported for duty. Recently Mr. William K. Holland and Mr. Jay H. Sheldon joined the staff. Business began to pick up and we soon found larger quarters were needed, so we picked up our files and typewriters and moved to more spacious and comfortable quarters on the second floor of the same building. During the year we found hundreds of positions in all kinds of work. From a handful of people who had evacuated voluntarily to Omaha, we have grown to a family of 355 in the District. Sixty-one families are represented in this number. These people are working on all kinds of jobs from professional, through semi-skilled to unskilled labor. Many are finding success on farms and all are experiencing a real satisfaction in knowing that their efforts are contributing to the winning of the war.

We are sorry to state that Mr. Walter N. Parmeter who has been in charge of the Omaha office since its inception finds it necessary to resign June 1, 1944, from relocation work because of the need for his full attention to other essential war work. Mr. Parmeter states that with the present efficient staff and the well organized office that relocation should make a rapid growth in the coming months. He takes this opportunity to thank all of you for your splendid cooperation with the relocation program. He congratulates you on your courage, your perservance, and your ambition to make relocation successful. He wishes you good luck in all of your future endeavors.

#### SOCIAL EVENTS

The Omaha office has in its possession, for the next few days, the soundmovie film "Go For Broke" which shows the activities of the Japanese-American soldiers in Camp Shelby. Since this is an excellent picture, we believe that you will enjoy seeing it. Therefore, while the picture is available, you are all invited to attend an open house at the Parmeter residence, 118 North 38th Street, between the hours of 5 o'clock p.m. and 10 o'clock p.m. on Thursday, June 1. The picture will be shown at 5:30 p.m., 7:30 p.m. and 9:30 p.m.

#### DIRECTIVES FROM WASHINGTON

A new kind of leave has been made available to the Omaha District. It is called Trial Indefinite. This leave provides that evacuees can leave the Centers on Trial Indefinite Leave and work six months at any one job, after which time they may return to the Center if they feel they cannot successfully relocate on indefinite leave.

#### HOUSING

In finding desirable housing in Omaha, we believe that the people already relocated here can be of tremendous help to us and to other evacuees coming into Omaha. In studying the immediate housing situation we find that there are a number of families who are interested in changing from apartments to houses. If you are considering a change, please let us know of your plans in order that we may place another family in the quarters you are vacating. Also as you go about town, if you notice houses or apartments for rent, please call the office and let us know, for we find there are a number of apartments and houses for rent that are not being advertized in the newspapers; therefore, we do not know of them unless someone tells us. Many people who are living in Council Bluffs work in Omaha. If you are interested in such an arrangement, we will be glad to help you find living quarters in the Bluffs. Car fare from the Bluffs is only 2¢ more.

#### BE SURE TO WRITE TO YOUR FRIENDS IN THE CENTERS

Tell them about relocation opportunities in the area in which you live. Let them know that we have on file in our office <u>right now</u> 300 active offers in all kinds of work. Inform them that the Omaha office has forty farm offers, many of which have excellent housing facilities and good salaries. In Dawson County, near Lexington there is a splendid opportunity for group relocation in that there are many good farm offers in the same neighborhood where there is pump irrigation, and the tenant houses are above average, having electricity and water either in or close to the house.

Mr. Bill Holland, who is new to this office and whom you met at the last YWCA social left this morning for Rohwer and Jerome Relocation Centers to discuss group relocation in Nebraska, as well as other relocation opportunities in the Omaha District. ### NEWS AND HIGHLIGHTS

#### DIRECTIVES FROM WASHINGTON

To assist evacuees in relocating, the WRA will transport the household and personal effects belonging to an evacuee and his immediate family from a Center to the destination designated by the evacuee. The WRA will also transport household goods or personal effects which are in private or government storage. Transportation will be at government expense and shall include packing and crating but shall not include unpacking and uncrating or delivery at destination. Such transportation shall be via the most economic means. Tools and equipment or fixtures of an evacuees trade, business, or profession including farm machinery and equipment sufficient only for a family-sized venture and not more than 5,000 pounds in weight, also may be shipped at the expense of the government to the point of the evacuee owner's relocation. If you are interested in having any of your household goods or personal effects shipped to you, let us know and we will send you the necessary forms.

Radios and cameras are not considered contraband for American citizens of Japanese extraction living outside of the Western Defense Command, but possession of them by Japanese aliens is prohibited by Presidential Proclamation.

When you write to your friends who are interested in relocation, tell them about Trial Indefinite Leave which now applies to the Omaha district. Anyone taking this leave may work six months at any one job, after which time they may return to the Center if they cannot successfully relocate on an indefinite leave.

#### DIRECTIVES FROM WASHINGTON

The following instruction recently was received from our Washington office which will be of interest to resettlers attending school and their parents who may be living in the Centers:

"No charge shall be made for either meals or quarters in the case of students who come to visit their families during official vacation periods of their educational institutions, provided that they have not graduated from school, and they intend to return to school when classes are resumed.

"If the student does not intend to return to school, and does not intend to use his leave to relocate, his case shall be handled like any other case of termination of leave and return to the center."

A few days ago, we received official information that the Military Intelligence Service Language School at Camp Savage has been closed and moved to Fort Snelling, Minnesota. We are also advised that the school is seeking one more class of American men of Japanese ancestry who are linguistically qualified as candidates Basic training of eight weeks will begin on December 1, 1944. In addition to seeking one more class of men of Japanese ancestry, they are also wishing to secure some women of Japanese ancestry who are likewise linguistically qualified to serve in the WAC's. #### DIRECTIVES FROM WASHINGTON

We have again been called upon to ask any potential travelers that they refrain from making trips between the dates of December 15 and January 8 of the new year. As you are all well aware, the holiday season always presents a large rush at the bus and railway stations. While travelling is congested at all times, it is requested that unless a trip is vitally necessary the space be left for service men and women who try to visit their families for the Christmas season and to other persons whose travelling is absolutely essential.

\*\*\*

One of the government agencies handling important and interesting war work is anxious to employ additional Issei and Nisei to serve as Japanese language translators; writers and type-setters in Japanese; and Japanese-style artists and illustrators, Applicants for translator positions must have a very good command of the English language as well as the Japanese. Persons applying for the positions as artists are not required to know the Japaneze language. For the writer positions, it is preferable that applicants have some college education in Japan and Japanese journalist experience. At the present time, these are not civil service positions but may in some cases be converted to civil service at a later date. Beginning salary for all of these positions is approximately \$2300. The locale is Washington, D. C., and all expense of travelling to Washington will be paid by the biring agency. In addition, board and room will be furnished to all employees. Physically fit and well-qualified men and women, preferably between the ages of twenty and forty, will be considered for these positions. If anyone is further interested, we would be glad to have them come to the WRA office where we shall explain the proposition in detail.

#### JOB OFFERS

There are many openings available for skilled and semi-skilled workers, laborers, restaurant workers, gardeners, watch repairmen, and many others. When you write to your friends in the Centers, please tell them that we have many opportunities here which should be to their liking and that the sentiment in Omaha is very good, making it an excellent place in which to relocate. We encourage the single persons who are here to write to their parents relative to the possibilities for relocating here, the object being family unit relocation.




