

Be it Remembered, that on this second day of March, Anno Domini One Thousand Eight Hundred and Fifty-three, before the Commissioners to ascertain and settle the Private Land Claims in the State of California, sitting as a Board in the City of San Francisco, in the State aforesaid, in the United States of America, the following Proceedings were had, to wit;

The Petition of Paula Sanchez de Valencia
for ^{part of} the Place named
"Buriburi"
was presented, and ordered to be filed and docketed with No. 744 and is as follows, to wit;

Upon which Petition the following subsequent Proceedings were had in their chronological order, to wit;

San Francisco January 9th 1853.
Case no. 744, Paula Sanchez de Valencia et al. for part of the place named "Buriburi" was ordered to be placed at the foot of the 4th class cases on the Trial Docket.

San Francisco January 23rd 1853.
Case no. 744 was submitted without argument and taken under advisement.

San Francisco January 30th 1853.
In the same case Commissioner R. Aug. Thompson delivered the opinion of the Board respecting the claim;


Petition

Doña Paula Sanchez, and Valencia
the Unknown, William Cary Jones, Marcelina
Felix de Sanchez and others, heirs and
Assignees of the Late Doña Sanchez de Felix,
give notice that they claim two undi-
vided fourth parts of the Rancho of Buriburi
in the County of San Francisco in said
State. Said Rancho of Buriburi in
the extent of four square leagues was
granted by the Mexican Government to
the Late Don José Sanchez deceased; and on
his death passed to his children ten
in number in equal undivided properties;
of which said children were the said
Doña Paula Sanchez de Valencia and the said late
Doña Sanchez de Felix deceased.
The original papers of the said grant are
not in the possession of these claimants;
and they ask leave to produce such proof
of its existence and contents as they may
be able to procure, and such other
testimony as may be necessary to establish
the rights herein claimed.


Decree






