



The Petition of *Sarah Ann Merdie* ^{for the} Place named "*Sos Carreros*," was presented, and ordered to be filed and docketed with No. *802* and is as follows, to wit;

Upon which Petition the following subsequent Proceedings were had in their chronological order, to wit;

San Francisco March 2^d 1854.
In Case no. *802*, *Sarah Ann Merdie* for a part of the place named "*Sos Carreros*," the deposition of *Gilbert A. Grant*, a witness in behalf of the Claimant, taken before Commissioner *Peter Sott*, was filed;

San Francisco January 9th 1855.
Case no. *802* on motion of the Counsel for the Claimant with the consent of the *W. S. Law Agent*, was ordered to be placed at the foot of the *4th Class* Cases on the Trial Docket.

Your Petitioner Sarah Ann  
Prodic of the County of Napa respectfully  
represents that on the 9th day of May 1836  
Manuel Chico then Governor of Upper California  
granted to Nicolas Heigura a tract of land  
now situated in said County known as Las  
Carneros containing six Spanish leagues, as  
will more fully appear by the papers on file  
in this Office of the Secretary of this Commission  
in the case of Joseph P Thompson (No 35A)  
and which Your Petitioner desires leave to refer  
make proof if necessary that on the 14th day of  
August 1853 said Heigura conveyed a part  
of said lands to James H Brackett of which  
the premises now claimed by Your Petitioner is  
incapable to procure or admit to by petition a copy  
of said conveyance of said Heigura to said  
Brackett but craves leave to produce and  
prove the same.

Your Petitioner further shows  
that on the 5th day of April 1851 the said  
James H Brackett by John C Brackett his  
attorney in fact by and of that state a copy of  
which is annexed marked B conveyed to Your  
Petitioner that part of said lands so aforesaid  
conveyed to him by said Heigura described  
as follows.

That tract of land lying in  
Napa County commencing at the point where  
the East line of the land of Paul P Walker  
touches the small creek thence running South-  
easterly along said East line five hundred yards  
to a stake thence running along the South line  
of Bracketts land five chains thirteen links  
thence running Northwardly parallel to the

East line of said Weckus land to the Small  
creek and thence up the Small creek to the  
place of beginning.

That Your petitioner has  
been in the peaceable possession of said land  
since the conveyance thereof to her and that  
the same is not claimed by any other person  
to her knowledge & she therefore prays that  
the title thereto may be confirmed.



This Indenture made this fifth day of April A D 1851 between John E Brackett atty for James W Brackett late of Plapa County California of the first part and Sarah Ann Modie of the same County of the second part, witnesseth that the said party of the first part in consideration of the Two hundred and forty dollars to him in hand paid the receipt whereof is hereby acknowledged hath granted bargain and sold and quit claimed and doth by these presents grant bargain and quit claim unto the said party of the second part and to his heirs and assigns forever that certain tract of land lying in Plapa County California commencing at the point where the last line of the land of Joel P Munkie touches the small creek thence running Southwardly along said East line five hundred yards to a stake, thence running along the South line of Bracketts land five chains & ten links - thence running Northwardly parallel to the East line of Munkies land to the small creek & thence up the small creek to the place of beginning containing about Twelve acres of land. Together with all the appurtenances

To Have and To Hold the land above mentioned unto the said party of the second part his heirs and assigns forever.
