The Petition of *Harriet Besse* <sup>part of</sup> for the Place named "*Sassen's Ranch*," was presented, and ordered to be filed and docketed with No. 498 and is as follows, to wit;

Upon which Petition the following subsequent Proceedings were had in their chronological order, to wit;

*San Francisco January 9 '1855.*  
Case no. 498, *Harriet Besse* for part of *Sassen's Ranch* was ordered to be placed at the foot of the 4<sup>th</sup> Class Cases on the Trial Docket.

*San Francisco January 23 '1855.*  
Case no. 498 was submitted under the Rule of March 21 '1854.

*San Francisco April 14 '1855.*  
In the Same Case Commissioner S. B. Farwell delivered the Opinion of the Board rejecting the claim,  
(Vide page 11 of this Transcript.)  
and the following order was made, to wit,

Petition

To the Honorable the Land Commission  
of the United States for the Settlement of Private  
Land Claims

Your Petitioner Horner Bessie  
of the county of Butte respectfully represents  
that in 1844 five leagues of land called  
Bosquij situated on the River Sacramento  
on both sides of Deer Creek known as Lassens  
Ranch

Now in the county of Butte were gr-  
anted and conveyed to Peter Lassen of said  
county by the Government of Mexico as well  
more fully appears by reference to the several  
papers.

Remitted them with files in the  
Office of the Secretary of this Commission  
in the matter of the appropriation of said  
Lassen (number) 182. of which your  
Petitioner may have to refer.

That on the  
30th day of June 1847 said Peter Lassen  
then being in lawful possession of said  
lands by deed of that date a copy where-  
of is annexed number A for a valuable  
Encumbrance Paid to him,

and the which  
in said Exhibit states conveyed to Daniel  
Sill the Factor of your Petitioner the lands  
within number B of Deer  
Creek

That said Sill thenceforth took poss-  
ession of said lands erected a house  
and made valuable improvements thereon  
that on the Sunday day of April 1851 said  
Daniel Sill,

By deed of that date a copy  
whereof is annexed number B. conveyed to  
your Petitioner said portion of said lands  
as a part of said conveyed to him by said  
Peter Lassen as under as follows

all that  
five square situated on the north side  
of Deer Creek bounded as follows com-  
mencing at the junction of Deer Creek

with the Sacramento River thence running  
westwardly along said River one Spanish  
League across said Deer Creek according  
to the Survey made by William Ide  
Thence

one Spanish League to said Deer Creek  
Thence

Westwardly along said Creek to the place  
of beginning that your Petitioner claims  
directly after the execution of said survey and

lands thereby conveyed to her and has ever  
since that time been in the peaceable  
possession thereof;

And as there is no ad-  
verse claims your Petitioner therefore  
presents in making proof of this  
matter, having set forth that title to said  
lands may be confirmed.

Know all men by these presents that I Peter Lassen do this day grant and give to Dannie Hill all right title and interest to all the land houses and improvements which I claim north of Deer Creek

The running quarant stones of the mill & up to said Hill to have full possession on the first day of September 1847 provided said Dannie Hill be as hurried to command finish off the house which said Lassen is building on the south side of the creek

Said Lassen being hurried to give said Hill a warranty Deed for said land as soon as he can get me hurried Independence June 30th 1847 Peter Lassen

 her heirs executors and administrators  
 from released and discharged from the  
 same by these presents have granted bargained  
 and sold all and sundry tenements tenements  
 messuages and curtilages and by these presents  
 do Grant bargain sell all their tenements re-  
 lease curtilage and curtilages to the said party  
 of the second part and to her heirs and  
 assigns forever all that certain piece  
 or parcel of land situated on the north  
 side of Deer Creek bounded and described


