



Your Petitioner Robert McThomes of Colusa County in the State of California respectfully represents that he claims a certain tract of Land called the "Elders," (Saucos) lying and being on the West side of the Sacramento River in the said County of Colusa beginning at the Mouth of said Elder Creek and bounded by the said Elder Creek on the North and the River Sacramento on the East the said tract as appears more fully by the original Map accompany the Expediente on file in the Archives being in the form nearly of a square Your Petitioner claims the same in full ownership by virtue of a grant made to him under the Authority of the Mexican Government by Manuel Micheltonino Governor of the Department of the Californias bearing date the 20 of December 1844 and approved by the Departmental Assembly on the 8th of October 1845 Your Petitioner would further represent that sometime in the year 1845 he solicited judicial possession of the said tract of Land of the respective Magistrate of the Sacramento District but the said Magistrate failed to comply with his demand And further Your Petitioner would represent that about this time he took possession of the said tract of Land and has been ever since, and is now in the peaceful possession of the same Your petitioner presents herewith the original grant and a certified Copy of the original Map with the original Confirmation of the Departmental Assembly in the Spanish language, together with a translation of the same Wherefore Your petitioner prays Your Hon^{ble} Board to take into consideration his title herewith annexed and claim to said Land and decree and confirm the same to be a valid title and such other & further relief as the nature of the case and justice and equity may require As in duty bound &c

 part of the time in the Sacramento Valley I am acqu
 anted with Robert Mc Thomas & have been since Decem
 ber 1843, In November 1845 he took possession & made
 improvements on a tract of land on the west banks
 of the Sacramento river where the town of Tehama
 now stands, He built at that time a substantial
 log house on the land and a large Corral & put on
 over three hundred head of black cattle & a number
 of horses & brood mares and he has continued in the
 occupancy of the land ever since, He has now not
 less than fifteen hundred head of cattle on the place
 A portion of the land has been under cultivation, encl
 oed with rail fences & ditches

Henry J Thorton one of the Commissioners for ascertaining and settling private Land Claims in California; came John A Sutter a witness produced in behalf of the Claimant Robert Mc Thomas being No 107 on the docket of said Commissioners and after being duly sworn testified as follows The Law Agent of the U. S. being present Questions by Claimants Counsel

Q 1. What is your name age & place of residence?

Ans. My name is John A Sutter My age forty nine (49) years My residence is Rock Farm Sutter County State of California

Q Do you know Robert Mc Thomas the Claimant in case No 107?

Ans I do know him and have known him since 1843

Q Do you know whether he ever got a grant of land; and if so by whom was it made

Ans He did get a grant of Land made by Genl Micheltorona

Q Examine the Original Grant filed with the Petition in this case and the Map and the Approval of the Departmental Assembly contained in document marked Exhibit (B) and say if you have seen them heretofore; and if so when?

Ans I have examined the papers marked (B) now here shown to me I saw the original title and a like Map in May 1845 but the approval of the

Assembly I have not seen until the present time
5- Are you acquainted with the hand writing of Manuel
Micheltorena of Manuel Jimena of Pio Pico of Jose
Maria Covarrubias; And if yes if or not whenever they
appear on and upon the document referred to, they
are then genuine signatures;

Ans I am acquainted with the signatures of the persons
named above and their signatures where they occur
in and upon said document marked (B) are genuine
6- When and for what purpose was the document
being the original title and a like map which you
say you saw in May 1848 shown to you and by
whom?

Ans These documents were brought to me and pre-
sented to me by Mr Robert Mc Thomas in the fall
of 1848 as I believe who as the owner of the land
granted requested me to give him judicial possession
of it because I was the authorized person at that
time to give judicial possession to grantees in that
District

7- Did you or did you not give him as requested
such judicial possession, and if you did not, state
the reasons fully why you did not do so? at that
time or subsequently?

Ans At that time circumstances prevented me
as the distance from my residence to the farm of
Mr Robert Mc Thomas was very great being about
one hundred and fifty miles I could not give him judi-
-cial possession as I was then engaged in a Military
Campaign with Genl Micheltorena immediately
after my return from the said Campaign I had to
go out again in a Campaign against the Indians
Soon after my return from the Indian Campaign
led Fremont came into that Section of the Territory
with his party, and a general revolution followed
throughout the Country I soon ceased to exercise
Military Authority and or Civil jurisdiction for.

 their reasons I could not comply with his request
 8— Do you know if Robert Mc Thomas at the time he made application for judicial possession had cattle which he was bringing to the land which had been granted to him by Gov^r Michittorina

Ans— Hee had a large number of Cattle but I do not recollect exactly the quantity and also horses which he was bringing to land granted to him for the purpose of stocking it He was in Company with Mr A.G. Toomes

Questions by the Law Agents

1 At what precise time did you go out on the Campaign with Genl Michittorina?

Ans On the 1st of Jan'y 1845 and I returned on the 1st of April of the same year

2— At what time did you go out on the Indian Campaign and return?

Ans I started on the Campaign as early as the middle of the month of April 1845 I am very confident that I started within that month on the Campaign against the Indians we were out on the Indian Campaign only a few days, as near as I can recollect we returned about the 17th or 18th of April 1845—

3 When did Col Fremont come with his party to that part of the Country?

Ans It was in the Spring of 1846

4— How long did you exercise Civil Jurisdiction in that District?

Ans Until the 15th of June 1846

5— Do you know the time that Robert Mc Thomas applied to you for judicial possession?

Ans It was in the fall of 1845—

Examination Continued by the Claimant

1 Were you engaged in the fall of 1845 when Robert Mc Thomas solicited judicial possession in any Military or Civil duties which rendered it impracticable for you to go with Mr Thomas to give him judicial

possession of the land granted by Governor Macchittorina as appeared by the title and Map which were presented to you.

Ans I was at that time engaged in Military and Civil duties of an important Character which prevented my going so great a distance to give him judicial possession as solicited. The Country at that time was in a very confused and distracted State and I could not consistently with my Civil and Military duties then pressing upon me leave "Nueva Elvicia" to give possession as solicited. The Country continued in this distracted State until the Revolution of June 1846 headed by Col Foremont

Questions by Law Agent

1 State specifically what were the Civil and Military duties you were engaged in which prevented you from giving Mr Robert Mc Thomas judicial after his application?

Ans My Civil duties were those as Justice of the Peace My Military duties were as Commander of the Fort to keep it ready at any time to obey the orders of the Government and for fear something might occur I could not leave for so long time

2 - What was impending that led you to have such apprehension?

Ans Because there was two parties in the Country and an Order from the Governor could have come and called me on duty for assistance. This was the State of things nearly the whole time after the application until my duties ceased the parties referred to above were those of General Castro and Pio Pico

Citizen Manuel Muchittorina Brigadier General of the Mexican Army Adjutant General of the Mexican Staff of the same Governor Commandant and general and inspector of the Department of the Californias Whereas Don Roberto Mc Thomas a Naturalized Citizen of Mexico has solicited for his personal benefit the land known by the name of the Elders (Saucos) bordering on the Sacramento River in the East beginning at the Elder Creek and containing five square leagues according to the accompanying Map the previous investigations and measure having been taken agreeably to the Laws and regulations and by virtue of the power conferred upon me I have in the name of the Mexican Nation granted him the aforementioned land declaring to him the Ownership by these presents subject to the approbation of the Most Excellent Departmental Assembly and to the following conditions

- 1st He cannot sell, alienate or mortgage it, impose land rent, entail, bond or any other burden
- 2nd He may enclose it without prejudice to the Cropping highways + servitudes he shall enjoy it freely and exclusively putting it to the use which may best suit him but within a year he shall build a house and it shall be inhabited
- 3rd He shall solicit the respective Magistrate to give him legal possession in virtue of this title by whom the boundaries shall be traced out in the limits of which he shall put besides the land marks some fruit trees or wild ones of some utility
- 4th The land of which donation is made consists of five square leagues as is explained by the respective Documents

The judge who gives his provision shall cause it to be measured according to Ordinance and the surplus shall remain to the Nation for its convenient purposes

5th If he shall violate these conditions he shall forfeit his right to the Land and it may be denounced by another I therefore Command that these presents being held as firm and Valid an entry thereof be made in the register book and they be delivered to the party interested for his security and further ends

They approve of the Conception made by the Superior Governor of the Department in the title issued on the 20th of December 1844 in favor of the Naturalized Mexican Citizen Robert H Thomas of the place known by the name of the Eldeas (Saucos) situated on the borders of the Sacramento River of the extent of five square leagues in conformity with the Law of the 10th of August 1824 and of act 5 of the regulations of the 21st of November 1828 and for the security of Don Robert H Thomas this is given

The Claimant has presented an Original grant for the land claimed made to himself by Governor Manuel Michettonna bearing date December 20th 1844 with a certificate of the approval of the same by the Departmental Assembly on the 8th of October 1845. The genuineness of these documents is proved by John A. Sutter who also swears that he saw the grant and a map of the land similar to that now attached to it in the fall of 1845. When the grantee applied to him to give him judicial possession of the property the engagements of the witness prevented his giving the possession of the land and it seems that no official act of measurement and possession was ever obtained.

A traced copy from the Archives of the Expediente is also presented which shows an application by the Claimant for the grant made in due form the usual proceedings to obtain information, the Governor's decree, of Conception and the grant above mentioned.

The premises as described in the grant consist of the land known by the name of Saucos bordering on the Sacramento River on the East beginning at the Saucos Creek and containing five square leagues according to the accompanying map. And in the conditions of the grant the land is stated to be "five square leagues as is explained by the respective documents".

The description in the petition in the petition according to which the Conception was made described the land as bounded on the North by the Arroyo of Saucos on the East by the River Sacramento on the South by the land asked for by Mrs. Josefa de Voto and on the West by the Vacant lands as explained by the accompanying map and containing five square leagues, the map is evidently prepared with much

Case representing the Sacramento River as running towards the South and the Sarcos flowing into it from the West nearly at right angles with it And the premises granted are defined by lines drawn to represent the four sides of the same being bounded on the East by the Sacramento and on the North by the Sarcos on the West by a line parallel to the Sacramento and on the South by a line parallel to the Sarcos This location is precisely in accordance with the description in the Documents - And indeed it would seem that the location could admit of no doubt with the additional aid of the Map which is made a part of the description by the reference to it in the grant No difficulty exists in the location of the premises according to the calls of the grant and no judicial measurement was needed for that purpose The grant contains the condition that the grantee shall within one year build a house on the premises which shall be inhabited the grant was made December 20th 1844 and the testimony of Pearson B Reading and Peter Lopez show that in the month of November 1845 the grantee went on to the premises and made improvement built a substantial log house and a large Corral and took his stock there that he has continued in occupation ever since that a portion of the land has been under cultivation enclosed with rail fence and ditches and that he has never had less than fifteen hundred head of cattle on the place.
