

San Francisco April 24th 1854

The Petition of Ralph G. Kilburn and John E. Br
-ackett respectfully shows

That on the ~~15th Dec 1848~~
granted to Manuel Baca a certain tract of land
called Los Pinos and more particularly described
in the original title papers which are filed in claim
no in the office of the Secretary of this Board hereby
referred and prayed to be made a part of this
Petition

That on the said Boca sold
and conveyed to your Petitioner a certain portion of
said tract more particularly described in the deed of
conveyance a certified copy of which is herewith sub
mitted marked B.

That said portion consists of five
-ten hundred acres (1500) of land more or less
Your Petitioner further shows that said land
has been ever since the date of the and is now in the
quiet and undisputed possession of your Petitioner
and those under whom he holds

That he relies for con
-firmation of his said claim upon the title papers
above referred to and upon such other and further
proofs as he may be advised are necessary

Wherefore
he prays confirmation of his title to said land

That the said Manuel Baca for and in consideration of the sum of three hundred and twenty five dollars well and truly paid at or before the sealing and delivery hereof the receipt whereof is truly acknowledged hath granted bargained sold transferred and conveyed and by these presents doth grant bargain sell transfer and convey unto the said Kilburn and Brackett their heirs and assigns forever all his right title and interest of in and to all that certain lot of land situated and being in the District of Sonora as aforesaid described as part of a certain grant of land granted by the Government of Mexico to said Baca and Bannan as follows to wit

Commencing in the Encina creek at the mouth of the first branch that empties into said creek (Encinas) on the North side running thence to the mouth of a small branch being the Southern line of the land of S. J. Hoppe thence up the said branch half way up to the mountains west of the residence of said Baca thence a Southern direction along the side of said mountain until it strikes Encina Creek down the said creek to the place of beginning containing fifteen hundred acres more or less according to the annexed map of the land


To Have and to Hold all and singular the above bounded and described lot of ground as aforesaid together with all the rights profits privileges and appurtenances whatsoever then unto belonging as fully as the same was held and possessed by the said Baca as aforesaid unto the said Kilburn and Brackett their heirs and assigns to their only proper use benefit and behoof forever and the said Baca for himself his heirs and assigns doth truly covenant to and with the said Kilburn and Brackett their heirs and assigns to

same







The Petition alleges a grant of the place called Los Pinos to Manuel Baca and a deed from him to the present claimants of the portion described in the Petition

A certified copy of such deed from the Records Office of Solano County is presented but no other evidence is given in the case. There is nothing to show that the Petitioners or any of them had any interest in the land or that the Mexican Government had divested itself of its ownership of the premises.


