



Square Leagues more or less, granted to them on the
31st of May 1840 by Juan B. Alvarado then
Governor of California, under authority of the
Laws then in force, and which grant does in
due form approved by the Departmental Council
on the 26th of May 1840

They have occupied and resided upon the land
from the date of the grant down to the present
time.

They know of no other claim to any part of the
Land.

They file herewith a copy of the Expediente certi-
ficate by the Surveyor General of the U. S. for
California, marked "Exhibit A" with a transla-
tion thereof marked "B"

In support of their claim they rely upon such

this Land and about the improvements upon it
If yes, state all you know

Ans. I do know every thing about the Occupation of this
Land. The Grants Sebastian Forcella and Jose
Fernandez had a house upon the land before
the grant was made. They lived there themselves
and had cattle and sheep upon the Ranch -
They have lived on the Land ever since and are
living there now with their families. At first they
lived together, but about six years ago they separated
and since then have established separate Ranchos
upon the Land, each of them having stock of
cattle and cultivating a part of the Land

This day before Com^r Thompson Campbell came James
Alexander Fales, a witness in behalf of claimants
Sebastian Pratta et al Petition No. 386 being duly
sworn deposed as follows:

What is your name age and place of residence
My name is James Alexander Fales, I am forty
Eight years of age and I reside in Santa Clara

Do you know the Rancho called Encina de
los Gatos, and if so, how long have you known it
and where is it situated?

I do know it. I have known it for twenty odd years
it is situated in the County of Santa Clara, about
Six miles to the South of the Mission of that name
It is bounded on the North by lands of the said
Mission of Santa Clara and lands Occupied by
Augusta Norberg, on the East South East and
South and South West by the Sierra de Santa Cruz
on the West by a stream some times known by the
name of Los Lobos, but most generally by the name
of Tomas Aquino. The boundaries as I have described
them are well known, that the land between them
and this indicated I do not know are so distinct
ly defined. All I know is that they join at that
corner. The other lines are noted boundaries of
mountains and a stream on the West. The place
took its name from said stream of Los Gatos which
runs through the land

Look on the paper now shown you, and purporting
to be a true copy of the Original Expedient and
marked "The Plot and State whether the map
contained in said document represents correctly
the place called Encina de los Gatos -
I recognize this to be a correct sketch of said land
the stream running through its centre is the Arroyo
Los Gatos, that which is delineated on the Western
side is the de Tomas Aquino. I recognize also there
two patches of brushwood Chaparral, one on the
Eastern side and the other on the Western side of the
Arroyo Los Gatos. The brushwood is still there.
I recognize the delineation of the route from Santa
Clara to Santa Cruz, which route is now the County

road and is used at this time, when the road
crosses the stream is a well known crossing place
The Arroyo del Gatos was sometimes called the
Arroyo del Rancho



Opinion

This is a claim founded on a grant made by Governor Juan B Alvarado on the 31st day of May 1840 duly confirmed and approved by the Departmental Assembly on the 26th of the same month and the certificate of the same dated 18th of June 1840 delivered to the parties. The evidence shows that the parties had a house on the land in which they lived before the grant was made and continued to reside until about six years ago when they separated and established separate Ranchos on the land in which they have continued to reside ever since - that each had a stock of cattle. The genuineness of the original grant and certificate of approval is satisfactorily proved by competent testimony, and the conditions of the grant appear to have been fully complied with. The only remaining question is, as to the sufficiency of the description to locate and identify the land. It is described in the body of the grant "The place known by the name of the Rinconada de los Galos" the boundaries of which are shown by the map; and the third condition defines the land granted as one and a half leagues sitios de ganado Maya as is shown the map; a judicious measurement is required with the usual reservation of the sobrante or surplus to the Nation, the word "Rinconada" signifies, angle, point, or corner and a reference to the map contained in the true copy of the Expediente from the archives shows a tract of land lying in the angle or point formed by two ranges of mountains and bounded thence on the East and South, on the West by a creek and on the North by a line drawn nearly East and West from Saca Creek to the Sierra or Mountain Range on the East; with the Arroyo del Rancho or Los Galos on the South, nearly through the center of the premises. The testimony also verifies the correct map of this description. From all the evidence in the case it would appear that to have been the intention of the Government to grant to the parties the quantity of one league and a half square leagues of land known as the Rinconada embracing the corner or

angle which is formed by the mountains on the East and South and bounded on the West by the arroyo and on the North by a line drawn in the direction represented on the map, from the creek to the mountain so as to enclose and segregate the one and a half square leagues which are granted. With this description added by the map and taken in connection with the long occupation of the claimants a surveyer would find but little difficulty in identifying and locating the precise limits of the land intended to be granted. A decree of confirmation will accordingly be entered.


