



The petitioners Jose del Carmen Lugo, Jose Maria Lugo, Vicente Lugo and Rago Sepulveda respectfully represent,

That on the 21st day of June A.D. 1842 Juan B. Alvarado Governor of California by virtue of authority in him vested granted to the petitioners the tract of land called San Bernardino, situate in the present County of Los Angeles, containing eight square leagues with the boundaries described in the grant, and corresponding map as shown in the Expediente, a certified copy of which is submitted herewith marked "A" with a translation marked "B".

That said grant was subsequently duly approved and the possession given in due form a translation of which saidicial act of title is submitted herewith marked "C". That the petitioners have been for more than ten years and now are in the quiet, peaceful and undisputed possession and occupation of the said tract of land. That they know of no conflicting claim. That they rely for confirmation of title upon the original title papers issued to them by the Government upon the Records and minutes in the Archives now in the possession of the Surveyor General, and upon such other and further proofs as they may be advised are necessary.

Wherefore they pray the Commissioners to confirm to them the aforesaid tract of land.

On this day before me, N. and M. one of the Commissioners for ascertaining and settling Private Land Claims in California came Neb Stearns, a Witness produced in behalf of the Claimants Jose del Carmen Lugo et al being No 316 on the docket of said Commissioners and after being duly sworn testified as follows.

The U. S. Law Agent was duly notified and attended.

In answer to questions by Counsel for the Claimants, the Witness testified as follows.

My name is Neb Stearns, my age fifty four and my residence the City of Los Angeles. I have resided in California over twenty three years.

I am acquainted with the hand writing & signatures of Jose del C. Lugo, Manuel Dominguez, Ignacio Coronel, Raymundo Martin, Manuel Jimeno, Antonio Maria Cis, Juan B Alcarado, Santiago Arguello & Francisco Alcarado. Their several signatures, appearing upon a paper now before me purporting to be the title & return of the giving of Judicial possession to the Claimants of the Rancho San Bernardino are, I have no doubt their genuine signatures. Said paper is hereto annexed and marked Aot.

I am acquainted with the land described in the papers before mentioned & have been for seventy or eighty years. The Claimants I think put cattle on the land in 1841 & built a house there the next year. It might have been the same year. They continued in possession until they sold out to the Mexicans in October or Novr 1851. The average number of cattle which the Claimants have kept on the land I should think would be about eight thousand.

In answer to questions by the Law Agent, the Witness says that he thinks the land is not within ten leagues of the Sea Coast. I think the Mission of San Gabriel occupied the land with cattle as late as the years 1832 or 1833. The Claimants have had some ground under cultivation but I cannot tell the quantity.

On this day Cyron Holland Yeall one of the Commissioners to ascertain and settle private land claims in California, came Eulogio de Celis a Witness produced in behalf of the Claimants Jose de la Cruz Lago & Co whose petition is No 316 on the docket of the Board & was duly sworn. His evidence being given in Spanish was interpreted by the Secretary.

The United States Law Agent was notified & attended.

In answer to questions by the Comr for the Petitioners, the Witness testified as follows.

My name is Eulogio de Celis. My age is forty four years. I reside in the City of Los Angeles & have resided in California over twenty years.

I am acquainted with the hand writing and signature of Don B Alvarado. I have examined the signature of said Alvarado appearing upon a paper now shown me purporting to be his certificate of the payment of eight hundred dollars in produce dated April 1. 1816 & I believe said signature.

to be genuine. I am the person named in said paper as having received the payment. I received the payment in the year 1842 or 1843 in which it amounted to Eight hundred dollars from which there should be a deduction of fifty dollars which I paid for transportation. It was received from Jose de la Carmin Lugo & I credited the same hundred & fifty dollars to the Government of California. I was authorized by Gov. Alvarado to receive the payment & credit it to the government.

It was customary when lands were granted by the Governor which had been occupied by Missions & upon which there were buildings or improvements to require payment to be made to the Government for them. I believe that Lugo had received grants of that description & that the payment was made in consequence. The Government of California was indebted to me in larger sum for the transportation of prisoners to Mexico & the payment was made by Lugo in part satisfaction of my claim. The paper before mentioned is hereto attached & marked A.

Citizens José del Carmen, José María, and Vicente Lago and Diego Sepulveda, who signed as and the first, representing the others, before Your Honor with due respect present myself and say, that in virtue of a permission given me by the Superior Government of the Department, I went to establish myself in the Rancho of San Bernardino, with the understanding that the persons who were preparing to go, at the time I made representation to his Excellency the Governor would accompany me with the object of forming a colony in that Rancho but unfortunately after that petition was granted, although the Colonists were invited they almost all failed, and only my brothers complied with their promise. In order to obtain the first object, I have endeavored to procure persons to form the establishment and the greater number objected. Then in virtue of my petition to the Government, I went to settle in the aforesaid place and built a house and corral at the Agua Caliente, I and my brothers put on it more than four thousand head of cattle and in short I formed my settlement. Under these circumstances the aforesaid Diego Sepulveda said that he would go to accompany me, locating himself at Yucaipa. As the place is included in San Bernardino I made no objection to this being done. On so doing I found that the Magistrate Don Ignacio Palomares wished to present it, and the said Sepulveda as he told me, had to go to ask leave of said Señor Palomares, the latter having called Your Honor by surprise in order to get from you the permission to place on Yucaipa, a part of

20

his Cand of Honor (it being by my consent that the said Magistrate was allowed to put on and carry off his Cand of Honor from said Place, and as I wished to carry out the favor which the Superior Government granted me, I endeavored to take three Persons to form the Colony. For this reason I told Citizen Diego Sepulveda to settle there, and in effect he was building a wall house, but Senor Palomares in a manner prevented its being finished, sending me a letter as to your Excellency, that the Property we had in Yucaypa should be taken off, thus proving the fact that the place was not as I have come to know he informed Your Honor in accepted. For it was occupied and in virtue of a Superior permission. Having seen that in spite of my endeavors I cannot obtain persons who wish to settle as Colonists and noticing that individuals possessions are asked for, as Senor Palomares has done, although he is owner of the place of San Jose so much more pleasant and advantageous than that of Yucaypa which he now asks for. I petition for the four persons aforesaid and who subsides the place of San Bernardino in fact, in extent eleven square leagues a little more or less, which are contained in the map which I duty transmit. Hoping that Your Honor on placing this petition before the Superior Government will be pleased to make Your Report in conformity with the Justice, which assists us, both because we are already settled in that place by Superior permission for about two years. Because we have the place now covered with more than six thousand head of large Cattle, and because it has been my care to make great improvements in San Bernardino, where in spite of difficulties and some danger we have remained and continued the labors of Agriculture.

For this reason, Senor Prefect, I pray and beseech Your Honor to present this petition to the Superior Government hoping that his Excellency will accede to it, which favor I together with the others implore - protesting that which is necessary is.

Most Excellent Sir,

In conformity with the request of him who is Chief in  
this representation I send it up to the Superior hands  
of Your Excellency with the report which this Prefecture  
deems to be best.

The Prefecture in my charge under-  
stands that the Señores Lugo established themselves  
in San Bernardino with permission from the Depart-  
mental Government granted in the character of a Colony  
in virtue as I understand it of their having offered to  
establish a Town in those lands, but as this was not  
done (for it is seen that up to this time those who rep-  
resent have not complied with their offer) It should  
not now be understood that Yucapia property belongs  
to the Place of San Bernardino in case the latter is granted  
for a Barcho and not for a Town because it is inde-  
pendent of it being distant about three leagues.

They refer to the fact that the Magistrate  
Don Ignacio Palomas owner of the place San José  
without reflecting that they themselves actually pos-  
sess a large portion of land in the neighborhood of the  
City of Los Angeles the Place of Santa Ana of the Chinis  
that of San Bernardino and the Agua Caliente which  
are of great extent so that these lands being sufficient  
for the property of the Señores Lugo, it is necessary that  
other persons Cauto señores, should occupy those  
which they can without prejudice to any person.

They also say that the Magistrate Palomas  
in virtue of his authority, ordered them to take away  
from Yucapia the Cauto which were then, that I believe  
he did not by the authority which he now represents  
but by the right to that Place derived from the

provisional grant by this Prefecture that he might place there his cattle for the present year on account of the scarcity of pasture in San José, which were all burnt, and in Guacapa they abounded as if there was no one to consume them. For the same reason Palomaris permitted Diego Sepulveda to put his cattle on Guacapa but he (Sepulveda) went on to build a small house, and this was what Palomaris presented as I am informed. Notwithstanding the foregoing Your Excellency will be pleased to decide as may be Your Superior pleasure. For this Prefecture believes that if it should not explain itself in this manner the effect would be to prevent others from enjoying the benefits which nature has supplied.

I make this short manifestation for the sake of Justice as it is my duty and to bring to light this class of rivalry between persons equally deserving of being attended to for if Palomaris occupies the place of Guacapa it is in virtue of the aforesaid permission and he has previously asked for it in fee as I represented to Your Excellency in the respective report.

This Prefecture then finds no objection to there being granted to those who represent the places of San Bernardino, Agua Caliente and Jimanba which are those which they actually occupy with their property, if it should be Your Excellency's Superior pleasure.

ten rooms and a Caero yard, one tile kiln, and a  
lime kiln and a ditch for irrigation, in continuation  
after examining these he showed us below down than  
the first, three rooms and a wall of stone in ruins, ob-  
serving that no room is roofed and all somewhat  
dilapidated. This is every thing belonging to the  
Mission which exists there, at the examination of which  
Don Jose del Carmen Lugo did not appear because  
when we gave him notice the robbers had stolen his  
horses and he was absent and in our opinion we thought  
that we ought not by waiting for said Senor to lose  
his time in making the examination.

Not the detailed report which is requested  
of us as the matter is not very profound, it appearing to  
us very simple, we can do no more than add that these  
buildings being abandoned they cannot at this time  
have their proper value, and could only be repaired  
in the hands of a cunning man, in virtue of this for the  
foregoing and what we know from having seen it

Although our knowledge is not great in any branch  
 We are of opinion that the value in which the aforesaid  
 buildings in San Bernardino ought to be estimated  
 should be three hundred and fifty (350) dollars a  
 sum which we have considered just in the condition  
 they are in, understanding that on this matter we have  
 acted with the best intentions, without having any inter-

José del Carmen, D. José María Vicento Lugo and D. The Claim in this Case presents a demand on a grant made by Juan B. Alvarado Governor of California on the 21st of June 1842 in virtue of the decree of the 12th of August 1825 and of the ordinance of the 21st of November 1828 of the Mexican Government to the Claimants for eight square leagues of land. It does not appear that the Claimant ever applied for or obtained the approval of the Departmental Assembly of this grant. On the 3rd of August 1842 in the usual form Judicial measurement and delivery of possession of possession of the land was made. There was a house built on the place and occupied in the year 1842. it was stocked largely with cattle and horses and has ever since that time been in the possession of the Claimants and those holding under them. The genuineness of the grant and the authority of the Governor who made it are not controverted, all the facts above stated are established in the Case by a transcript regularly authenticated from the Public Archives of the former Government of the Country, by original documentary evidence and the testimony of witnesses whose depositions are in file. All the objections made to a confirmation of the Claim have been fully considered and overruled by this Board in the case of Cruz Corsantos and of others hitherto decided and in accordance with the principles of decision laid down for our Government in the 11th Section of the act of the 3rd of March 1851. We think the Claim is valid and proceed to enter a decree of final Confirmation. Commissioner, Hall Concurring in the result.

And your petitioner further represents, and alleges, that the said claim of Jose del Carmen Lugo, Jose Maria Lugo, Vicente Lugo and Diego Sepulveda for said land claimed, and confirmed by said Commissioners as aforesaid, is invalid, and said decree of Confirmation erroneous, on the following grounds.

1. That the said Jose del Carmen Lugo, Jose Maria Lugo, Vicente Lugo and Diego Sepulveda show no valid title to the said land claimed by them as aforesaid. And it is denied that they have any.

2. That the said Claimants have no title or interest in the land claimed, they having sold the said land to the Mormons, and quit the possession of the same, in October or November AD 1851.

3. That at the date of the said alleged grant, the said land claimed as aforesaid was occupied by the Misiones of California; and particularly by the Mission of San Gabriel with valuable houses, Mills and other improvements thereon.

4. That the grant was not made in accordance with the Colonization law of August the 18<sup>th</sup> AD 1824; nor according to the regulations of the 21<sup>st</sup> of November AD 1828, in this, that the title was issued and signed by the Political Chief before the approbation of the Territorial Deputation.

5. That it does not appear that the alleged grant, was ever approved by the Territorial Deputation or Departmental Assembly; and it was not so approved.

6. That if the grant is an Empresario or Contractor grant, then it does not appear that the Grantees obligated themselves to settle twelve families <sup>on the land</sup>; and it is denied they so obligated themselves.

7. That it is not stated in the said grant that it was made in entire conformity to the disposition of the laws.

8. That the said grant was made by said Governor Alvarado, upon a Consideration in Money (\$800.) or its equivalent; which was not in accordance with, and was contrary to law.

9. That the second condition of said grant was not performed, as required; that the Magistrate did not measure the land in accordance with the terms of the grant.

10. That the Judicial measurement and possession was unauthorized by the Magistrate, the title presented to him by claimants, not showing the approval of the Deputation.

11. That said alleged act of Judicial possession and measurement by Manuel Dominguez was not upon sealed paper; that in the measurement of the land he did not proceed according to the ordinance, or law, nor in accordance with the calls of the grant and map referred to therein; that the said alleged grant is for the place called San Bernardino, of the extent of Eight square leagues, a little more or less (*poco mas o menos*) as explained by the map, which belongs to the expediente, and the said Dominguez in giving possession, violated the terms of said grant, and exceeded his authority by measuring and giving possession to said claimants of a tract of land greatly exceeding in extent Eight square leagues of land, a little more or less; that said tract of land of which Judicial possession was given to said claimants by said Dominguez, greatly exceeds in extent Eleven square leagues.

13. That there is no evidence that the said Manuel Dominguez was a Judge at the time of the alleged act of possession, having lawful Authority to make the Judicial measurement and give the possession of the land granted by Governor Alvarado as

14. That the description of the land, in said alleged grant and map, is vague and uncertain; and that the description of the land, in said alleged act of Judicial measurement and possession is also vague and uncertain.





The claim in this case is founded on a grant from Governor Bonilla to the present claimants, bearing date 2<sup>d</sup> June 1842. The genuineness of the grant is fully proved — Judicial possession of the land was given — and the evidence shows a substantial compliance with the conditions of the grant, the objections to the validity of this grant have all been considered in other cases decided by this tribunal — and overruled.

The claim must therefore be confirmed to the extent ~~allowed~~ for in the grant within the limits ~~bonilla~~ is described in the grant and map. provided there be such quantity & sit (cujus & quae tenent) within said boundaries or if there be less than said quantity then to such less quantity.
