



The petition of Urbano Cuenca and Manuel Saegans and of Sebastian Romero all of the County of Los Angeles, respectfully shew to the Hon Board that they claim the three first as tenants in common in fee each one fourth and the last as tenant in common in Conditional fee of one fourth of a certain tract of land situate in the said County called "El Escorpion" and consisting of a half a league less or less. They further shew that they claim said tract as aforesaid in virtue of a grant from His Excellency Don Juan Manuel de Rivera the Californias made under the authority of the Mexican Government & in pursuance of powers vested in him by law bearing date 7th August 1843, & made in favor of the three first named petitioners, who since that time to wit on the 26. July 1849 and 16 Sept 1851, have conveyed to the remaining petitioners one undivided fourth or conditional fee as will be more fully shown on the hearing of this petition. They further represent that the said grant has been approved by the Departmental Assembly & that judicial possession of the granted land was duly given to the original grantees on the 17th August 1845 by Juan Sepulveda 1st Alcalde of Los Angeles who marked off and accurately defined the boundaries thereof & that since that time they and the said Romero have had & now are in peaceful and quiet possession of the same. They further shew to the Hon Board that at the time of the said grant Urbano & Cuenca two of the grantees in virtue of two Acts of Governors of California to wit of Manuel Arriaga Casarin and of Manuel Micheltorena & that the other granted Manuel is the son of Urbano & Juana minor at the time of the Emancipation of his Father.

They further represent that all the conditions of the law precedent and subsequent have been properly fulfilled & that they know of no conflicting claim & they herewith submit copies & translations of the original grant & act of possession & they rely on the originals thereof as well as on such other documentary & verbal testimony as they may be advised may be

necessary, wherefore they pray Confirmation of their
title & each duty bound &c.

On this day before Commr Heland Hall came Juan Manso, a witness in behalf of the Claimants Urbano, Adon, Manuel et al. petition No 392 and was duly sworn his evidence being interpreted by the Secretary.

The W. S. Associate Law Agent was present. In answer to enquiries by the Counsel for Claimant the witness testified as follows.

My name is Juan Manso. My age is forty years & I reside in Los Angeles.

I know the Rancho called El Escorpion & have known it from the year 1846. It is situated nine or ten leagues from this place in a northwesterly direction. Since I know the place it has been occupied by the Indian named Urbano. When I first knew the place he had a house on it in which he lived with his family - had a vineyard cattle & horses which the Mission gave him for his good service & he cultivated the land. He continues to occupy it in the same manner to the present time. The land was a part

of the former mission lands of the mission of San
Fernando. I was a lessee of the lands of the mission
of San Fernando under the Mexican Government from
the first of Jan. 1846. to September 1852. & was in occu-
pation of all the mission lands as such. The occupancy
of Urbano has always been respected. I know the Indian
Manuel. He is reputed to be the son of Urbano. He is
from twenty four to twenty six years of age I think.

I know the Indian Adon. He has been
living on the place with Urbano & so has Manuel. They
had two or three small houses.

I was a Commissioner in
1845 to take an inventory of the property of all the
missions of California. I took an inventory of the
property of the mission of San Fernando & these
Indians were then in possession of said land.



Whereas the Indians of the Missions of
San Fernando. Urbano Cedon and Manuel. had
claimed for their personal Quifit and for that of their
families the tract known as the Escorpion which they

have possessed for some time the Extension of which is one half of a square league. the necessary steps having been taken according to the disposition of laws and regulations on the subject. using the facultis conferred on me, in the name of the Mexican nation I have come to grant to them by deed of this day the aforementioned land, declaring to them the ownership thereof by the present titles and in entire conformity with the laws subject to the approbation of the most Excellent the Departmental Assembly and under the following conditions -

1. They may fence the ground adjudicated to them without prejudicing the crossings, highroads and rights of way. they shall enjoy the same freely and exclusively. devoting the same to the use and cultivation which may best suit them, but within a year the land shall be occupied by a house, which shall be inhabited and proper stock.

2. They shall solicit the respective Judge to give them the Judicial possession in virtue of this patent by whom the boundaries shall be marked placing the necessary land marks.

3^a - The ground granted to them consists of only one half of a seat for large cattle the Judge who gives possession shall cause the same to be measured in conformity with Ordinance the surplus remaining for the benefit of the nation for its convenience.

I therefore order that the present title being held as firm and valid a record be taken of it in the appropriate books and that it be delivered to the parties interested for their Security.

Given at Las Vegas, Capital of the Department of the California the 7th of August 1845.

This title has been Entered of record in the appropriate book.

Las Vegas, May 8, 1846.

In session of to-day this Expediente was referred to the most Excellent the Departmental Assembly, ordered that the same be referred to the Committee on vacant lands.

The Committee on vacant lands have duly examined the foregoing Expediente promoted by the Indians of San Fernando, Mariano, Adon and Manuel of the tract of "Escorpion" which was granted to them by the Superior Government of the Department in accordance with the laws on the subject, in virtue whereof they submit to your deliberation the following proposition.

Approved the grant made to the Indians of San Fernando, Mariano, Adon and Manuel of the tract "Escorpion" precinct of Los Angeles according to the title issued on the 7th August last, of the extension of one half of a seat for large cattle, in conformity with the law of 18th August 1824, and Art. 5th of Regulations of 21st November 1828.



The petitioners allege that a grant of the land claimed was made to Ur Cano, Adon and Manuel the three first of the claimants named who were neophyte Indians of the Mission of San Fernando the first two of whom it is shown were emancipated by decree of the Governor issued while Manuel who was the son of Ur Cano was a minor.

The claimants have given in evidence the original grant above mentioned bearing date August 1, 1843, signed by Governor Pio Pico whose signature is duly proved. The Certificate shows that the grant was had under consideration by the Deputada Interal Assembly and a report was made by the proper Committee in favor of an approval, but no final action appears to have been taken on it by that body.

The testimonial of the proper Officer duly proved in this case shows that immediate possession was given to the grantees and the land duly measured and described on the 17th day of August 1843.

The testimony of Juan Mamed shows the occupation of the premises by the original grantees. He says he has known the place from the year 1846, "Since I know the place it has been occupied by the Indian named Ur Cano, when I first knew the place he had a house on it in which he lived with his family had a vineyard, cattle and horses, which the Mission gave him for his good service rendered them and he cultivated the land.

He continues to occupy it in the same manner to the present time." Adon and Manuel also lived on the place. The condition of the grant requires the grantees to have the premises within a year occupied with a habitable house and immovable property - It is contended by the Law Agent that the proof does not show that the occupancy which is proved by the witnesses commenced within a year of the making of the grant. But the subsequent portions of the Deposition from which the above quotation is

made explains more fully as to the time when the witness first knew the place. He was the lessee of the surrounding land during the whole of the year 1846. He also took an inventory of the property of the mission in 1845 and states that the grantees were then in possession of the land and he expressly declares that Urbano had a house and lived on and cultivated the premises when he first knew the place. This testimony establishes a full compliance with the above mentioned condition of the grant.

It is asserted by the claimants however that there was a mistake in the judicial measurement by which it would seem that the Officer gave possession of only about one fourth instead of a half of a square league of land and such from the return made by him seems to be the fact. It is however too late to correct the error.

The original grant petitioned for two leagues of the land the Governor granted them half a league requiring the party to obtain a judicial measurement in order to segregate the land granted and define its limits and boundaries.

If no such segregation had taken place at the time of the change of jurisdiction under the treaty of cession this grant could not be confirmed. It would be without limits and boundaries which have always been held necessary in order to establish title to any specified portion of land and to entitle the grantees to a confirmation by this Commission.

If this act of judicial possession is set aside as erroneous or fraudulent, the claim must be rejected altogether for without it no description is contained in any of the documents or testimony by which we can describe or confirm the land claimed.

If it be taken as evidence of the segregation of the land under the grant, it must be taken as it is and the description of the land therein contained must be followed in the deed of confirmation.

It is only in reference to boundaries that the judicial possession in this case is important and the measurement in giving such possession in this case was indispensable in order to define and designate the land which they could hold under their

grant. The portion which is thus segregated, we
can confirm, but if this does not embrace as many
acres as the grantee were entitled to have assigned
to them it is now too late to remedy the evil. This Com-
mission has no power to make new boundaries to
the premises or to give them a title to lands outside
these limits, as defined and settled under competent
authority before the ownership was transferred by the
treaty of cession to the United States.


