

To the Honorable Commissioners to settle Private
Land Claims in California.

The petitioner

Ruful Estrada respectfully shoves: That on
the 2nd day of December A.D. 1833, Jose Figueroa
Governor of California, by virtue of authority in
him vested, granted to Cristina Delgado the tract
of Land called "Rancho de las Salinas" situate
in the present County of Monterey and containing
half a square League of Land, a little more or
less as shown by the grant and corresponding map
which Original title and judicial possession are
submitted herewith Marked "A" and a translation
Marked "B"

That on the 3rd day of March A.D. 1847 the said
Cristina Delgado sold and conveyed the said
tract of Land to the petitioner which Original
Deed of Sale is submitted herewith Marked "C"
with a translation Marked "D"

The petitioner further represents that the petitioner
and the party under whom he holds have been in
possession since the date of said grant, and that he now is
in the possession of said Land and knows of no
conflicting claim

That he relies for Confirmation of title upon the
Original papers submitted herewith, the records
and Minutes in the Archives of the former
Government and upon such other and further
evidence as he may be advised is necessary

Wherefore he prays the Commissioners to
confirm to him the said tract of Land

This day before Com^r Alpheus Felch came David
Spence a witness in behalf Claimant Rafael Estrada
No. 535. who after being duly sworn deposed as
follows

Questions by Mr. Halleck Atty for Claimant

1st Question - What are your name age and place of
residence?

Answer - My name is David Spence, my age 53 years
and I reside at Monterey in California I have
lived in California twenty nine years

2^d Question - Examine the paper here presented to you
purporting to be the title and judicial possession
of the place called Rancho de las Salinas and
marked Exhibit No. 1 attached to the deposition

of Mr E P Starnell here before filed in this case and
State what you know about the papers constituting
the said Document.

Answer - In 1835 I gave judicial possession of said
Rancho as Alcalde, to Cristina Delgado. These
were the papers which were made out at the time
the possession was given by my Secretary and were
signed by me.

3rd Question - State what you know of the Occupation
of the Land described in this Act of Judicial
possession.

Answer - When I went to give the possession I found
Cristina Delgado living in a house which was
built on the place. There was also some land
cultivated by her and a few tame cattle on the
place - the number I did not know. She continued
to occupy and live on the place from that time until her
death, notwithstanding it had sometime before her death
been sold to Rafael Estrada. It was sold to him in 1847
and he moved onto the place immediately after the
purchase and continued to live there. She also lived
on the place in accordance with an agreement between
them. Estrada has built houses of his own on the
place has cattle upon it, and lives there now with
his family.

4th Question - Examine the paper now presented to you pur-
porting to be a deed of sale of said Rancho from
Cristina Delgado to Rafael Estrada hereto attached
marked "Exhibita No 1" with the initials A F and state
what you know of the Signatures there and of
its Execution.

Answer. My Signature appearing thereon is genuine
The Signatures of Jose M^e Estrada, Salvador Lomas
Santiago Ullson, J. S. Escamilla, Teodoro Gonzales
and Ambrosio Gomez, also appearing thereon are the
true and genuine Signatures of those persons respec-
tively. I saw them sign their names on this paper
as they now appear there.

5th Question - Was the Nature of the Contents of this paper
Explained to Cristina Delgado and did she under-
stand it at the time of its Execution?

Answer. It was all Explained to her and she under-
stood it, and desired to have it drawn in that
manner and she executed it freely and voluntarily.

1 Question. Say what you know of the alterations
the Certificate of Survey signed by yourself, which
appears on the Eleventh and twelfth pages of the
Exhibit No 1 above mentioned -

Answer. The first alteration on the Eleventh page
is a change from the letter ll on two places to the
letter O they are used for the word west and the
change was made to correct the spelling both me
aning the same point of the Compap. As to the second
alteration on the same page I do not recollect
about it and do not know why it was made

2^d Question State if you recollect the points and
causes in that Survey

Answer. I commenced the measurement a few hours
westward up the river above her house and
near the river bank, and ran about West South
West, passing the Salt Laguna, to a bank of sand
on the shore of the Bay. Then we took another
measurement, commencing in a corner near to the
mouth of the River (the Montuay or Salinas River)
and running up the river to the place of beginning.
These two lines and the shore of the Bay form the
boundaries of the land which is in a triangular
form. I do not recollect that we measured
along the shore -

3^d Question. Did Cristina delgado leave any children
at the time of her death?

Answer. To the best of my knowledge she had none

Question. Do the boundaries in the Survey as you
have just described them correspond with the
present reading in the report of judicial papers
on us now altered

Answer. They do, to the best of my recollection, I have
little doubt, though I do not exactly recollect

The claimant in this case has
filed in support of his title an Original grant from
Governor Figueroa to Cristina Delgado, dated Decem-
ber 2^a 1833 for the place called Rencón de las
Salinas to the extent of half a square league, and
a conveyance from said grantee to the claimant
dated March 2^a 1847 by which the title of said
grantee was transferred to him, reserving to himself
a right to occupy and enjoy the premises during the
term of his natural life. The genuineness and authen-
ticity of these documents and the death of the origi-
nal grantee are duly proven by competent testimony.
Judicial possession of the premises was given by
the Constitutional Alcalde of Montañá on the 12th
