
To the U.S. Land Commission for the consideration and setting of Private Land Claims in the State of California

The Petition of Manuel Castro a Mexican and resident of California respectfully sheweth unto your Honorable Body that on the 7th December 1843 he made and published his Petition to His Excellency the Governor of the Department of California soliciting for himself the grant of a piece of land known as Rancho de la Laguna de Tache a description of which will be given hereafter that said Governor and His Excellency the authority vested in him as Constitutional Governor of California granted your Petition the tract of land prayed for and directed the Secretary of State to execute and deliver the formal title papers

That on the 10th of January 1846 your Petitioner applied in person to the Commission for the execution of the formal grant purchased to him in the year 1843 as aforesaid and obtained the same on the 10th day of January 1846 under the signature of His Excellency the Governor of California and your Petitioner further saith that the copies of the original petitions and grants and maps are on file in the Archives of California now in possession of the U.S. Survey General for the State of California and the originals of all of said petitions and grants and maps together with the translations of the same are herewith submitted to the inspection of your Honorable Body

And your Petitioner further alleges that said tract of land is situate in the present county of Monterey contains nine square leagues of land and is bounded as follows on the North by the Rancho de los Nobres and the Rio de San Joaquin, on the West by the Sanjon (dry creek) de San Jose, on the South by the lands of Jeremiah Clarke and G.W. Beckh by the Laguna de la Tache and by the lands of J. G. Lemantour, on the West by the Sierra Nevada and your Petitioner further states that he has been in possession of said lands since the year 1843 and has exercised full and unlimited ownership over the same and is not aware of the existence of any conflicting claims with respect thereto to his own, therefore he claims to be the owner of said land and prays that your

answer I am acquainted with said Rancho have known it since 1845 or early in 1846

3rd Question Are you acquainted with Manuel Castro  
answer I am

4th Question State all you know of the occupation cultivation and improvement of said Rancho by whom when and how it was so occupied

answer In 1845 or early in 1846 I was on said Rancho and met Ysidro Villa there who was tending cattle there I asked him where place it was and he told me it was Manuel Castros and that he (Villa) was pasturing care of the stock for Castro on the same there was a small wooden house there in which lived said

Nella and other men who are servants of said Don Manuel Castro there was a legal title which they are just finishing when I was there

They had a small field on the bank of the River planted with melons and vig-stalks which they were enclosing and they were preparing another field for planting of about 100 yams but I saw a considerable number of cattle and horses there but said not pay particular attention to the number and do not know how many there are I have not heard said Rancho since and have nothing of the subsequent occupation





Pri Pci eldest member of the Honorable assembly of the Department of both Californias and Governor and intendant of the same  
Whereas the Citizen Mariano Castro has solicited for his personal benefit eleven square leagues in the Laguna de Tache in the District of Sonora which land was granted to him by my Predecessor Don Manuel Micheltreua in decree of 12th of December 1843 after having previously taken the necessary action and made the necessary investigations.

In exercise of the powers with which I find myself invested by the Supreme Government in the name of the Mex: can Nation I have concluded to grant the said Castro by these presents the ownership of the eleven square leagues of land (sitios de Sonora Mayor) in conformity with the Law of 18th August 1824 and Regulations of 21st of November 1828 and under the following conditions

1st He may fence it within six years to the cross-ropes and limits he will enjoy it fully and exclusively appropriating it to the use or culture that best may suit him

2nd He will solicit of the respective Judges give him judicial possession in virtue of this document by whom the boundaries are to be marked with the respective land marks leaving respect for all that shall be the property of Don Jose Leventura within any prejudice to which he may be subject






